#### 6. OBLIGATIONS AND DECLARATIONS

The Applicant declares and guarantees:

- a. to be aware of the fact that intellectual property rights and economic exploitation inherent or connected to the Areas are the exclusive property of VFD;
- b. that photographs or videos will not violate in whole or in part and in all of their uses the rights of third parties;
- c. that the data provided is complete and correct and that the Applicant is entitled to represent the company and the project indicated above;
- d. that he/she is practising his/her profession and that he/she has the authority to sign this Form;
- e. to indemnify VFD from any liability arising from its active and/or omissive conduct during the filming/photographing;
- f. that he/she will direct the filming/photographing under his/her own responsibility for all the consequent effects towards VFD and third parties;
- g. to have signed and maintain in force for the entire duration of the activities described in this Form a Liability insurance policy against third parties suitable to cover all damage to property and injury to persons which could result from the activities described in this Form with a limit of no less than  $\in 2,000,000.00$  (two million euros).
